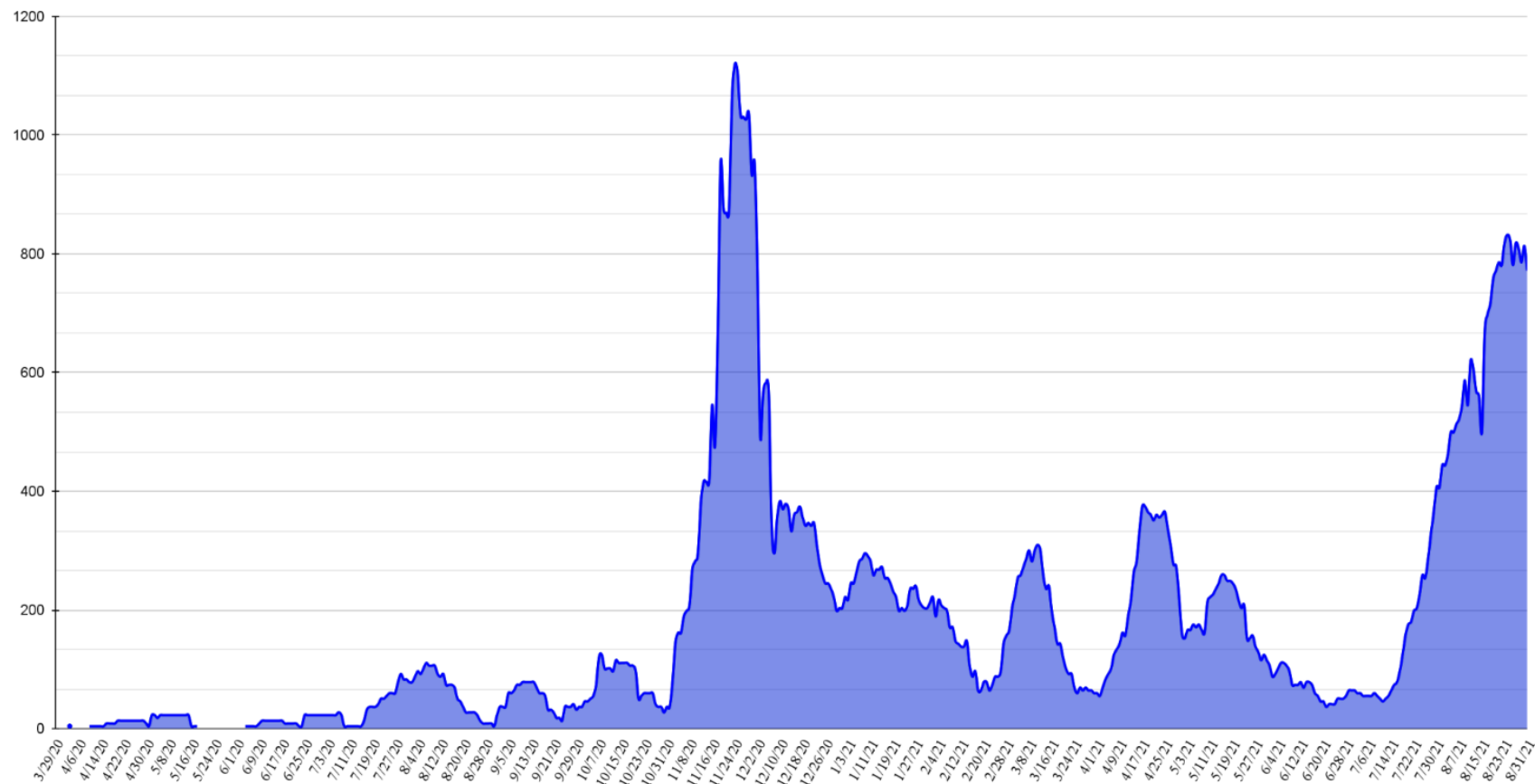

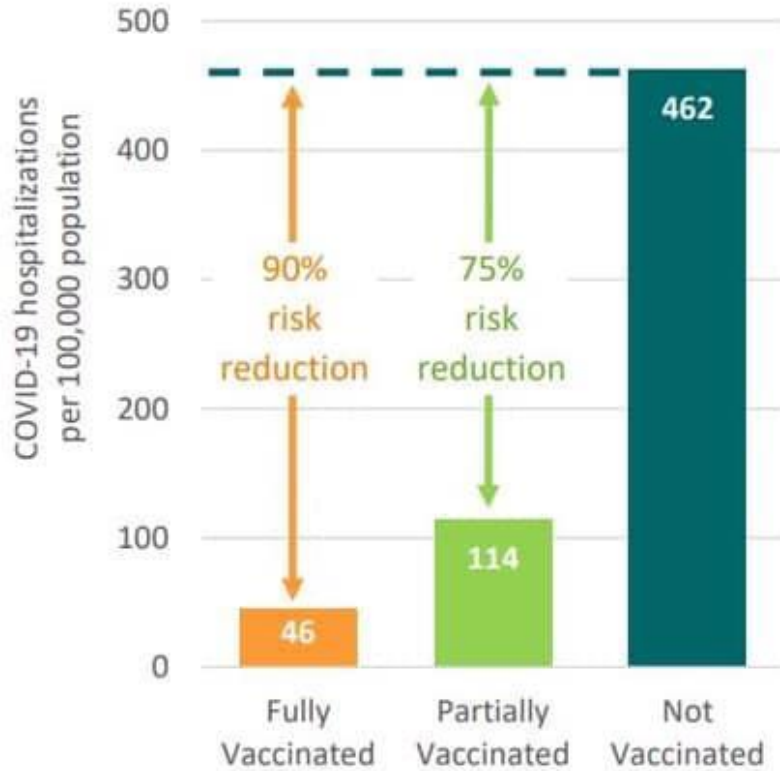

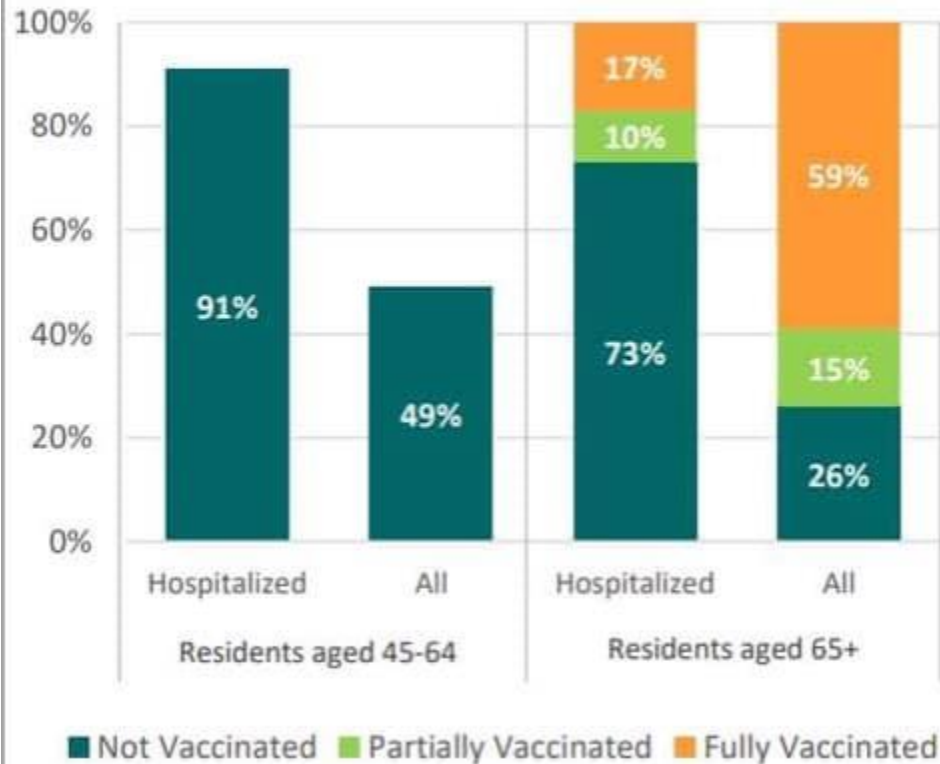
### COVID-19 hospitalization risk among SW Washington residents aged 65+, by vaccination status



- A new report released by Cowlitz County Health Department shows COVID-19 vaccination is significantly reducing the risk of hospitalization among residents in SW Washington.
- The analysis included residents of Cowlitz, Clark, Lewis, **Pacific**, Skamania and Wahkiakum counties who were hospitalized for COVID-19 from March 22 to June 27, 2021.
- The analysis found the risk of being hospitalized for COVID-19 was reduced by 90% for residents 65 years and older who were fully vaccinated. Of those 65 years and older who were partially vaccinated, the risk of being hospitalized was reduced by 75%.

by age, hospitalized vs all residents

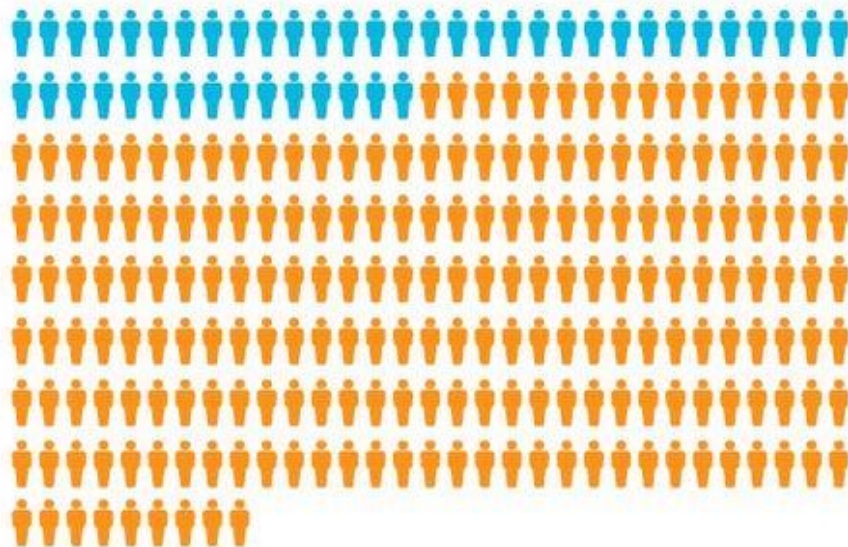


The data showed 91% of hospitalized residents 45 to 64 years old were unvaccinated. For comparison, 49% of the population in that age group in the region were unvaccinated.

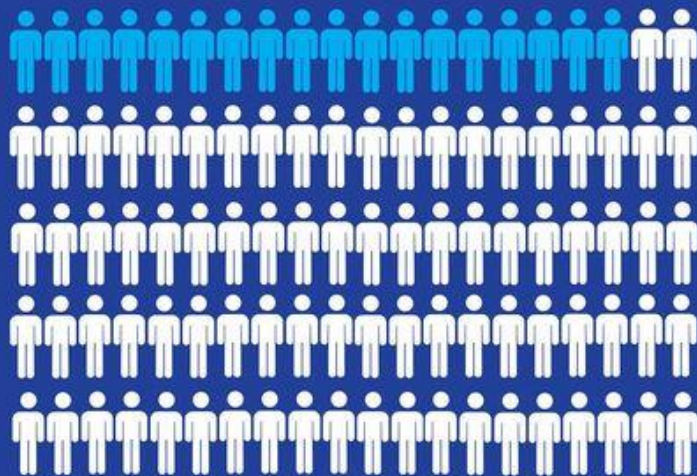

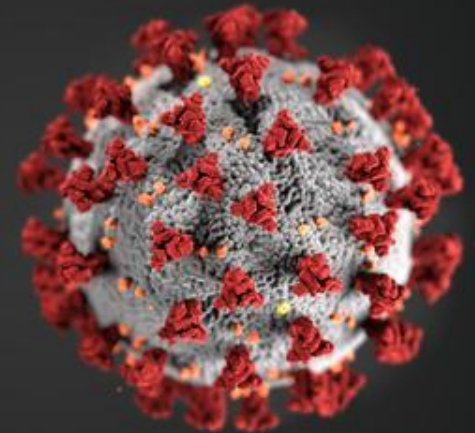


## The Pfizer COVID-19 vaccine is now FDA approved!

- On August 23rd, the FDA gave full approval to Pfizer's COVID-19 vaccine for individuals 16 years of age and older. The vaccine received emergency use authorization back in December, and millions of doses have been administered across the US.
- The vaccine also continues to be available under emergency use authorization, including for individuals 12 through 15 years of age and for the administration of a third dose in certain immunocompromised individuals.

# COVID-19 Vaccines

## 3rd doses vs Boosters:

### What's the difference and who can get one?

(For patients who received a primary series of an mRNA vaccine (Pfizer or Moderna))

#### THIRD DOSE

**What:** Additional doses (3rd doses) of Pfizer or Moderna are administered when initial immune response is insufficient.

**Who:** For individuals who are moderately to severely immunocompromised and who have already received 2 doses of an mRNA vaccine (Moderna or Pfizer).

**When:** Beginning August 13, Providers are authorized to provide a third dose of a mRNA vaccine to be given no sooner than 28 days after the initial two-dose series.

**Why:** People with compromised immune systems may not build the same level of immunity to 2-dose vaccine series compared to people who are not immunocompromised and they may benefit from an additional dose to make sure they have enough protection against COVID-19.

#### BOOSTER

**What:** Administered when the initial response is sufficient, but immune response has decreased over time.

**Who:** immune response is sufficient, but immune response has decreased over time. All individuals who completed a 2-dose mRNA series 8+ months ago will be eligible for a booster (but not yet!)

**When:** We estimate booster doses to be available beginning late September or October starting 8 months after an individual's second dose. At this time, individuals who were fully vaccinated earliest including many healthcare providers, nursing home residents, and other seniors, will likely be eligible for a booster dose first.

**Where:** Not available at this time. Booster clinic locations will be announced at a later date (after they are authorized)

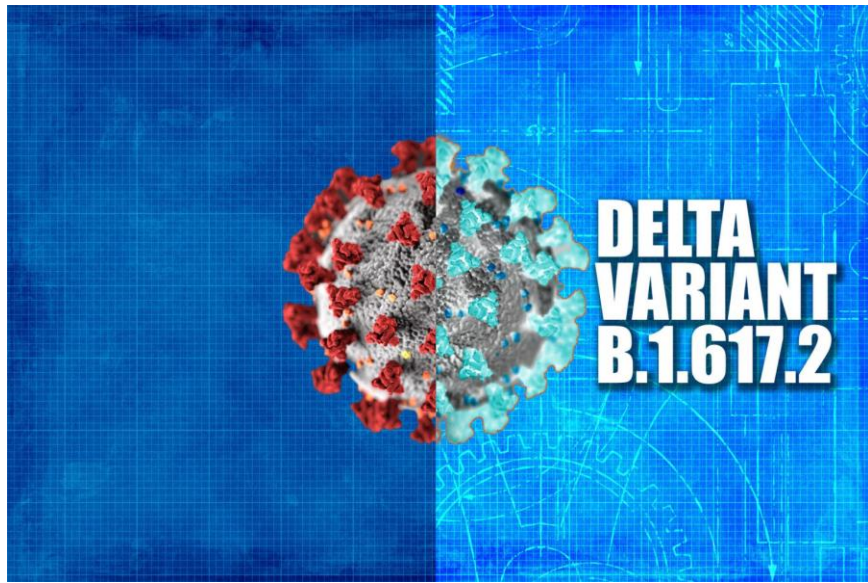
#### Third doses (applies to around 3% of population)

- For individuals who are immunocompromised only
- **Available now**

#### Booster Doses

- Coming soon (likely end of September)
- Will be for people who have completed a 2 dose series 6-8 months ago
- Waiting on authorization from the state before booster doses can be provided. **There are no booster dose appts available yet.**
- Likely to roll out in a prioritized order similar to initial vaccine roll out
- We will provide more information once we have it!





- The delta variant causes more infections and spreads faster than earlier strains. It's more than two times as contagious as previous strains.
- Some data suggest the delta variant might cause more severe illness than previous strains in unvaccinated persons.
- Vaccines continue to reduce your risk of contracting COVID-19, including against the delta variant. And the vaccines continue to be highly effective at preventing severe disease and death, including against the delta variant.
- Unvaccinated people remain the greatest concern, but a small proportion of fully vaccinated people may also get COVID-19 (breakthrough cases).

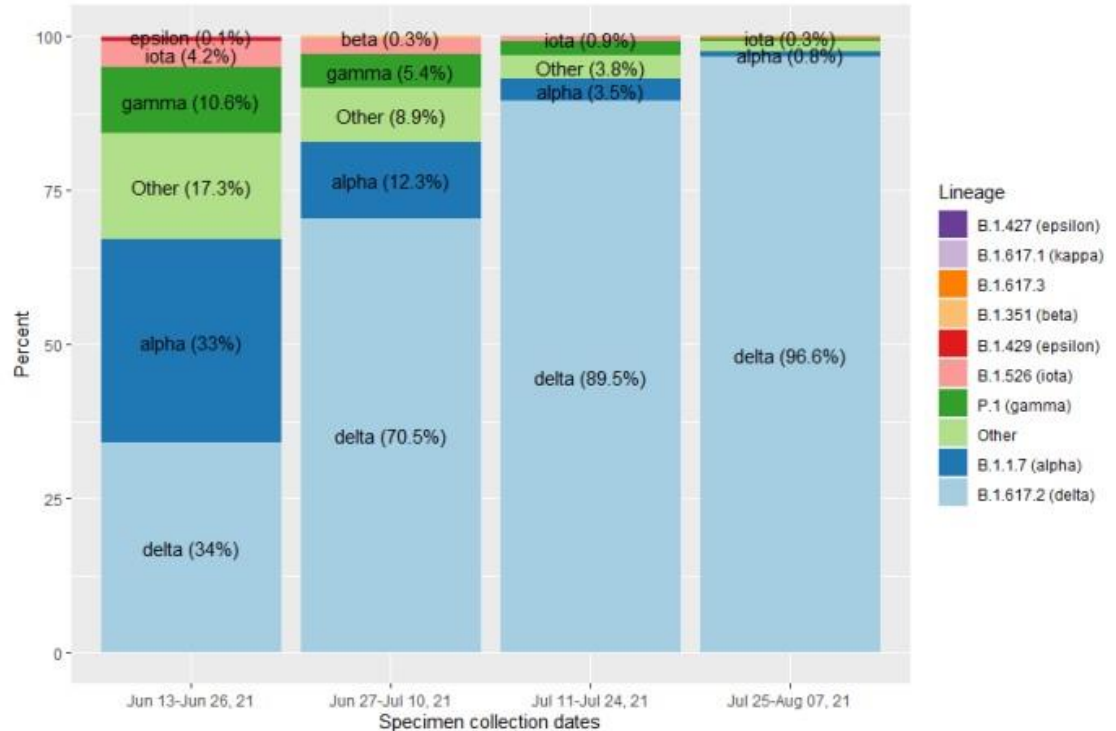
- People infected with the delta variant – including fully vaccinated people with symptoms – can spread the virus to others.
- Fully vaccinated people appear to be infectious for a shorter period than unvaccinated people infected with the delta variant.

- Sublineages of P.1 and B.1.351 (P.1.1, P.1.2, B.1.351.2, B.1.351.3) are aggregated with the parent lineage and included in parent lineage's proportion. AY.1-AY.12 and AY.3.1 are aggregated with B.1.617.2.

### Public Health Nurses will ask about:

- The places you have been and the people you have been around who may have been exposed.
- This includes those who you have been in close contact with for longer than 15 minutes, up to 48 hours before you had symptoms.
- Public health will notify those people about their exposure to the virus— we will not tell them about you.
- We have resources to help you and your family during your isolation or quarantine including grocery shopping, housing, rental assistance and more.

# COVID-19 From Exposure to Feeling Better



## If you were exposed to COVID-19...



1. Stay home.
2. Watch for symptoms.



- Fever
- Cough
- Shortness of breath
- Chills
- Muscle pain
- Headache
- Sore throat
- Loss of taste or smell

Symptoms appear **2 to 14 days** after exposure.



## If you have COVID-19 or COVID-19 symptoms...



1. Stay home.



2. Don't go to work or visit with others outside your home.



3. Call your doctor if you have symptoms, especially if you are over 65, have other health conditions, or are pregnant.

Stay in isolation until...

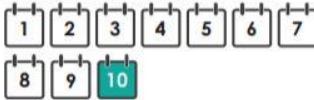
1. **24 hours** after your fever is gone without using medicine.
2. **Your other symptoms have improved** (for example, cough or shortness of breath).

## If you have tested positive for COVID-19:

Isolate for 10 days (after first symptoms or positive test result) and 24 hours after symptoms improve and you are fever free without the use of fever reducing medication (whichever is longer).

## If you have been exposed to COVID (Close Contacts):

Quarantine for 14 days. Public health nurses can advise on options for early release from quarantine.

## Quarantine & Isolation support is available

We have care coordinators available to support you and your family during your isolation or quarantine period (rent assistance, grocery delivery, housing, etc.)

- Testing capacity in Pacific County is very limited
- EVERYONE with symptoms or who has had close contact with a positive case should get tested, *regardless of vaccination status.*
- **Please refrain from using local testing resource for travel or other non-medical reasons at this time.**
- There is no need to repeat testing within 90 days of a positive test result.
- If you have been released from your isolation period by public health nurses, there is NO need to test again in order to return to work. We can provide a isolation release letter if your employer requires one.

# Mask Mandates

## In indoor, public places

Masking is now required for all in indoor public spaces, ***regardless of vaccination status***.

## At schools

Universal masking is also now recommended for schools, regardless of vaccination status. This is a legal requirement, schools do not have a choice. ## At work

Masks are still required in workplaces unless employers. This is a requirement that is enforced by LNI.



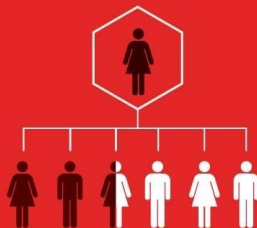

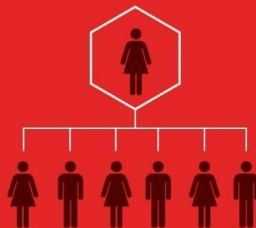

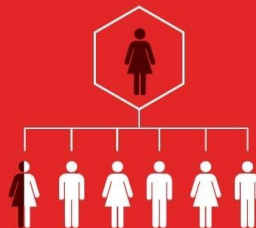

## GATHERINGS AND EVENTS GUIDANCE FROM PACIFIC COUNTY PUBLIC HEALTH

### **Any gathering is risky at this time.**

The highly contagious delta variant is spreading rapidly in our community. Hospitals are very full and have limited staffing capacity.

**You can help hospitals and keep schools open** by hosting events responsibly. It will take all of us to stop the spread of COVID-19.

**Make adjustments or cancel your event** if it cannot meet the following guidelines or your guests will not practice these safety measures. Consider hosting a virtual event.

## Host all events outside and do the following:

- ◆ Remind everyone to stay home when they: are sick or have any symptoms of illness, are waiting for COVID-19 test results, or have been around someone with COVID-19 in the last 14 days.
- ◆ Ask all guests to be fully vaccinated.
- ◆ Remind guests that it is safest for adults and children who are not vaccinated to stay home.
- ◆ Even though the event is outside, everyone should wear masks if it's crowded.
- ◆ Create space for guests to be at least 6 feet apart and limit the size of the gathering.
- ◆ Place musicians, performers, or people giving speeches more than 6 feet from the audience. Use a sound system.
- ◆ Serve food individually or in household groups. Create physical distance if people must wait in line.
- ◆ Make handwashing and hand sanitizing stations accessible.
- ◆ Clean and disinfect surfaces frequently.

## State Guidance: Multiple layers of protection

- Vaccination
- Masking required indoors for staff and students (ages 5+)
- Improved indoor ventilation
- Access to COVID-19 testing
- Stay home if sick policy
- Social distancing and spacing between desks when possible



## When to stay home

Students and staff need to stay home if:

- The student/staff themselves have COVID-19 symptoms or tests positive
- Someone in their household tests positive or has been diagnosed with COVID-19



## Masking



- All staff and students ages 5+ are required to wear a mask indoors.
- Families should make sure masks fit snugly and are cleaned or replaced often.
- Masks protect yourself and others from COVID-19 and other respiratory illnesses.

## Vaccination

The best way to stay healthy and avoid school outbreaks is for students, families and staff to **get vaccinated** for routine vaccinations and COVID-19 when eligible.

Teachers and staff are required to be fully vaccinated for COVID-19 by October 18.

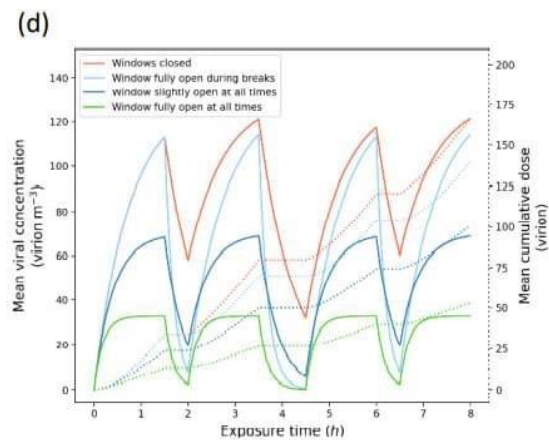
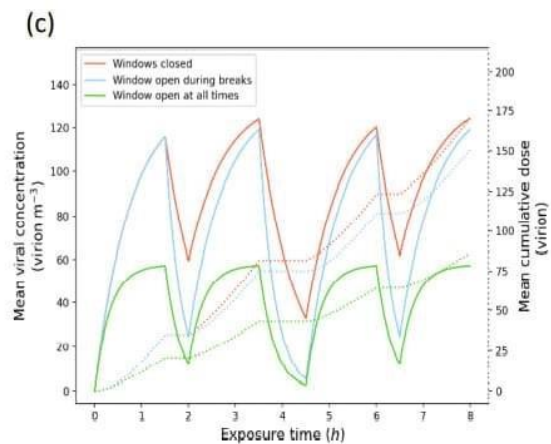
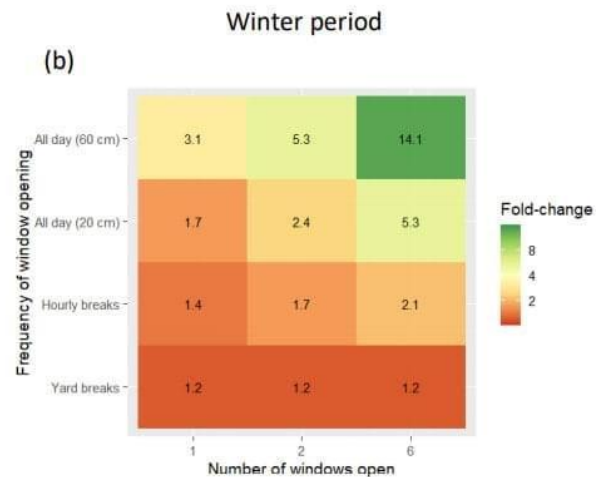
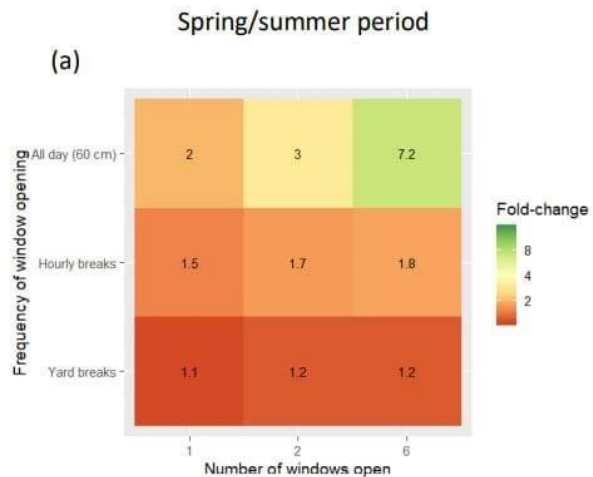
The state is not requiring masks outdoors, as long as physical distancing can be maintained. Some schools may require masks at all times.



## Lunch time

The CDC has provided guidance for meal times that schools can adopt based on their situation. These include maximizing physical distancing as much as possible, 6 feet or more is preferred, one-direction pathways, and outdoor lunch when/where possible.
