




# Pacific County Cases by Zip Code

- Not a representation of where COVID-19 exposure or transmission occurred.








- The best data we have available suggest that the COVID-19 vaccines still provide protection against infection and continue to provide strong protection against hospitalization.
- Since the Delta variant became dominant, fully-vaccinated residents have had 3-4 times lower case rates and 7-13 times lower hospitalization rates than those who were not vaccinated.
- Protection against hospitalization may be beginning to decrease among older adults.
- Older adults and others at high risk who have received the Pfizer vaccine over 6 months ago – will benefit from receiving a booster dose
- People aged 12 or older who are not vaccinated – will still benefit from getting vaccinated.



<sup>\*</sup>Case counts for fully-vaccinated residents aged 12-34 were too low to calculate rates at the beginning of the time period; partially-vaccinated rates suppressed to prevent back-calculation.





## Booster Doses... Who's eligible and how do I get one?

Pacific County providers are now offering booster doses of the Pfizer vaccine! The booster doses are currently recommended for people who received Pfizer for their first 2 doses and who completed their initial Pfizer series over 6 months ago, and fall into one of the following groups:

- People 65 and older; OR
- Residents in long-term care facilities; OR
- ➤ People 50-64 years old with underlying medical conditions; OR
- ➤ People 18-49 years old with underlying medical conditions; OR
- And people 18-64 years old who are at increased risk for COVID-19 exposure and transmission because of their occupation may receive a booster, based on their individual benefits and risks.

According to the CDC, occupations at increased risk for COVID-19 exposure and transmission include front line essential workers and health care workers, including:

- > First responders (healthcare workers, firefighters, police, congregate care staff)
- Education staff (teachers, support staff, daycare workers)
- Food and agriculture workers
- Manufacturing workers
- Corrections workers
- U.S. Postal Service workers
- Public transit workers
- Grocery store workers

If you meet all of the requirements above, you are eligible for a booster vaccine. Find a Pfizer clinic at <a href="https://www.pacificcountycovid19.com">www.pacificcountycovid19.com</a>

### **Booster Doses Continued... (FAQs)**

- Where can I get a booster dose? Answer: Anywhere offering Pfizer vaccine. The booster doses are the same as the
  first and second Pfizer doses, so you can get a booster dose from medical clinics and pharmacies offering Pfizer
  vaccine. You can find a location near you by searching www.pacificcountycovid19.com
- 2. **Can I get my booster dose at the same time as my flu shot?** Answer: Yes great idea! You can get your COVID-19 vaccine at the same time as other vaccines, including the annual influenza vaccine.
- 3. **If I need a booster, does that mean the vaccine isn't working?** Answer: No. COVID-19 vaccines continue to be very effective at preventing severe illness, hospitalization and death, including against the delta variant. But studies are showing that protection against mild and moderate illness may decrease over time, especially among certain higher risk groups. Getting a booster dose 6 months after completing the first two doses will provide an increased immune response and better protection against COVID-19.
- 4. **Am I still considered fully vaccinated if I do not get a booster?** Answer: Yes. People are still considered fully vaccinated two weeks after their second dose in a two-dose series (Pfizer or Moderna) or two weeks after a single-dose vaccine (Johnson & Johnson).
- 5. What about people who got Moderna or Johnson & Johnson vaccines? Answer: The current booster dose recommendations apply only to those who received the Pfizer vaccine. Federal health officials will review data on the Moderna and Johnson & Johnson vaccines in the coming weeks and may issue booster dose recommendations for those vaccines in the future.

## **COVID-19 Vaccines**

3rd doses vs Boosters:

### What's the difference and who can get one?

(For patients who received a primary series of an mRNA vaccine (Pfizer or Moderna)

#### THIRD DOSE

What: Additional doses (3rd doses) of Pfizer or Moderna are administered when initial immune response is insufficient.

**Who:** For individuals who are moderately to severely immunocompromised and who have already received 2 doses of an mRNA vaccine (Moderna or Pfizer).

**When:** Beginning August 13, Providers are authorized to provide a third dose of a mRNA vaccine to be given no sooner than 28 days after the initial tw-dose series.

Why: People with compromised immune systems may not build the same level of immunity to 2-dose vaccine series compared to people who are not immunocompromised and they may benefit from an additional dose to make sure they have enough protection against COVID-19.



#### Stay in isolation until...


1. 24 hours after your fever is gone without using medicine.

### If you have tested positive for COVID-19:

<u>Isolate</u> for 10 days (after first symptoms or positive test result) and 24 hours after symptoms improve and you are fever free without the use of fever reducing medication (whichever is longer).

### If you have been exposed to COVID (Close Contacts):

<u>Quarantine</u> for 14 days. Public health nurses can advise on options for early release from quarantine.

### **Quarantine & Isolation support is available**

We have care coordinators available to support you and your family during your isolation or quarantine period (rent assistance, grocery delivery, housing, etc.)

### Is it COVID-19 or is it the Flu?



COVID-19 symptoms might be confused with the flu, common cold, or even allergies. But COVID-19 and flu can be serious and lead to hospitalization, severe illness, and even death. Thankfully, both are preventable through vaccination. Use this chart to help identify common symptoms of each illness.





### If you are NOT fully vaccinated...

You <u>are not</u> a close contact of a positive case	Get tested  Isolate for 10 days or until you have a negative test result	No need to isolate, test, or quarantine

## Quarantine & "testing out of quarantine early"

Quarantine for close contacts last 14 days, but individuals may have an option to "Test out of quarantine" early. These options only apply if the person does not have any symptoms (remains asymptomatic the entire time)

- ➤ You may be able to end quarantine at day 7 with a negative **PCR** test taken between day 5-7.
- > You may be able to end quarantine at day 10 without a test if you have remained symptom free the entire time
- Early quarantine release must be approved by public health & school district and is contingent on adequate testing capacity in the community.

# Possible triggers to close an entire classroom or school

### **Possible classroom Closure Trigger:**

Two or more COVID-19 cases among students or staff within a 14-day period, who are epidemiologically linked, do not share a household and did not have significant contact outside of school grounds

### **Possible School Closure Triggers:**

- Schools with fewer than 10 classrooms: If 2 or more classrooms are closed
- Larger schools: If more than 10% of classrooms are closed
- If there is a rapid increase in cases
- ➤ If there are 2 or more generations of transmission
- If there is not enough staff for school to function

## **Face Coverings & Sports: Athletes**

### **Outdoors:**

- Masks are no longer required outdoors; however, unvaccinated individuals should wear face coverings outdoors in crowded public settings, including sporting events, where there is decreased ability to consistently maintain physical distance between non-household members.
- People are not required to wear face coverings while engaged in outdoor training or competition in any type of sport.

### Indoors:

- All individuals are required to continue to wear masks, regardless of vaccination status, indoors in K-12 schools except as noted below.
- Unvaccinated persons are required to wear face coverings when indoors in a place where people from outside their household are present or in a place that is generally accessible to people from outside their household.
- All athletes, including unvaccinated people, are not required to wear face coverings while engaged in indoor training or competition for low and moderate contact sports.
- All youth athletes should resume wearing face coverings when not actively training or competing.
- Unvaccinated athletes are required to wear face coverings indoors for high contact sports and in all indoor setting where children are/may be present.

## **Face Coverings & Sports: Spectators**

Spectators are required to wear face coverings while indoors. Face coverings are recommended but not required in outdoor settings with less than 500 people in attendance.

Face covers are required for everyone in outdoor settings with more than 500 people in attendance

### AGES 65 OR OLDER

Anyone 65 or older qualifies

Monoclonal antibody (mAb) therapy is available in Washington State with a provider's recommendation for certain high risk individuals.
