* High-risk populations are currently defined by CDC as: persons 65 years of age and older; people of all ages with underlying medical conditions (particularly not well controlled), including people with chronic lung disease or moderate to severe asthma, people who have serious heart conditions, people who are immunocompromised, people with severe obesity, people with diabetes, people with chronic kidney disease undergoing dialysis, and people with liver disease; people who live in a nursing home or long-term care facility.

Phase 3 Summary of Changes

Effective 7/20

Under the new Safe Start phase limits, the number of individuals allowed in social gatherings during phase three will be reduced to 10 people. . These restrictions apply only to social gatherings, not business operations operating legally under the Safe Start guidance. Funerals, weddings and religious activities are exempt from today's restrictions

Effective 7/20

A ban on live entertainment across WA State except performances outdoors for members of the same household where social distancing of a minimum of 10 feet is always maintained from the entertainer and facial coverings are worn by all individuals. “Live entertainment” refers to any activity in which an individual or individuals perform for an audience of an individual or individuals, where all are physically present. For purposes of this memorandum, “live entertainment” encompasses:

1. All musical performances, including but not limited to, group acts, soloists, and disc jockeys;
2. All stage productions, including but not limited to, theater, dancing, comedy, poetry, acrobatics, performance art, animal stunts, and adult entertainment;
3. Any combination of the activities above; and
4. All substantially similar activities.

Phase 3 Summary of Changes pg. 2

Effective 7/30

Restaurant guidance includes the following changes:

- Alcohol (beer, wine, spirits) service must end at 10:00 p.m. until Phase 4.
- Close down vending game areas (pool tables, darts, video games, etc.) until Phase 4.
- In Phase 3, table size reduced to 5 and occupancy reduced to 50% within restaurants.
- Bars (**including Private Clubs like Eagles, Moose, Elks, etc**) are closed for indoor service
- Indoor dining is limited to members of the same household until Phase 4.

No indoor family entertainment/recreational centers (mini golf, bowling alleys, arcades, etc.) until Phase 4.

No card or indoor card rooms until Phase 4.

Indoor movie theaters limited to 25% occupancy as a Phase 3 activity.

Fitness guidance to include the following changes:

Reduce Phase 3 occupancy to 25% capacity. All group fitness classes are limited to no more than 10 (not counting the instructor).

Phase 3 Summary of Changes pg. 3

Effective 7/20

Family Entertainment and Recreational Centers Indoor family entertainment and recreational centers, including miniature golf, putt putt, bowling alleys, indoor go-karts, arcades, and substantially similar activities, are prohibited.

Card Rooms Indoor card rooms are prohibited.

Movie Theaters Indoor movie theaters are prohibited until Phase

In Phase 3, indoor movie theaters are limited to a capacity of 25 percent.

Effective 8/10

Religious Weddings and Funerals-Indoor and outdoor occupancy is limited to 20 percent or 30 people, whichever is less, if and only if six feet of physical distancing between households can be achieved.

Only ceremonies are permitted, and ceremonies must follow all other provisions of the “Religious and Faith-based Organization COVID-19 Requirements.”

Receptions are prohibited.

The August 10, 2020, effective date of this section applies only if the event was planned before the date of this memorandum. Any events planned after the date of this memorandum must comply with the above rules starting July 30, 2020.

Effective July 25, statewide order requiring the use of face coverings will be expanded to include any shared spaces- This includes:

Shared spaces like elevators and hallways in apartment and condominium buildings, university housing, hotels and motels, congregate settings such as nursing homes, assisted living facilities, and adult family homes, Elevators & Hallway

When are facial coverings required?

- In public and indoors**
- In public and outdoors where you can't maintain 6 ft. physical distancing**

Potential COVID-19 exposure at Social Clubs on Long Beach Peninsula

South Bend, WA –Pacific County Public Health and Human Services is concerned that there was a high possibility of exposure to patrons visiting the Loyal Order of the Moose or the Fraternal Order of the Eagles in Ocean Park, WA.

If you were at the following social clubs during any of the listed dates and times, you should quarantine immediately for 14-days from date of exposure and watch for symptoms of COVID-19 (<https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html>). If you begin to show symptoms, you should get tested for COVID-19.



Confirmed Cases and Deaths by Illness Onset Date, and Hospitalizations by Admission Date


This chart shows the progression of the COVID-19 outbreak in Washington by cases, hospitalizations and deaths over time and is known as an epidemiologic curve. The epidemiologic curve is the curve referred to in the phrase, "flatten the curve."

152 of 54,205 confirmed cases do not have an assigned county. Illnesses from the last 4 to 7 days may not yet be reported.

Prepare for Quarantine or Isolation

Self-Preparations (Plan for 14 days)

- **Food:** Buy shelf-stable foods that are easy to prepare, like dry and canned goods and frozen fruits and vegetables. This can also include beans, peanut butter, granola, dried fruit, pasta, tuna and oats. Aim for at least 14 days of food for each member of the household.
- **Medications:** Check prescriptions to ensure you have at least a 30-day supply. Also, stock up on over-the-counter pain relievers and remedies like Aspirin, vitamins, electrolytes and cold and flu medicines.
- **First-Aid Kit:** Aside from medications, every home should have a first-aid kit to treat small injuries. It should include band aids, gauze, ointment, antiseptic wipes, a cold compress, a thermometer, tweezers and an emergency blanket.
- **Cleaning Supplies:** In addition to household supplies like rubber gloves, laundry detergent, dishwashing liquid and garbage bags, you'll need disinfectants to clean household surfaces.
- **Personal Hygiene Items:** Have basic toiletries like soap, toothpaste, toothbrush, etc. If you have small children, purchase additional diapers and wipes.
- **Household Items:** Have toilet paper and paper towel.
- **Pets:** Don't forget their needs too!

“Buddy” System (not a close contact)

Schools Reopening

- Due to recent increase in cases, Public Health is recommending at least a one month delay to reopening of in person school.
- Schools boards will make final decision for each district.
- Public health recommends assessing data on a month by month to determine if/when in person instruction should commence.
- When schools reopen to in person instruction, several mandatory safety practices will be implemented including: face coverings by all students and staff, daily symptom screening/temp checks, physical distancing, cohorts, increased cleaning/sanitizing, and plans in place to handle potential positive cases and outbreaks.

Personal and Business Assistance- Coming soon

Pacific County Cares- Applications will be available in August

- Up to \$10,000 grant program for small business (no more than 20 employees) affected by COVID shutdown
- Priority to businesses who didn't receive other funding (i.e. Paycheck Protection Program)

CDBG grant- Submitting application in Sept, awards by end of Sept. Will support:

- Up to \$750 to assist families with rent/utilities who have been affected by COVID rent/utilities
- Priority to families who haven't received other assistance
- Remainder to support public health response into 2021
