Four Mass Vaccination Sites Open Statewide this Week

The Washington State Department of Health (DOH), with assistance from the Washington National Guard and local and private sector partners, is launching four mass vaccination sites throughout the state this week. [Announced by Gov. Jay Inslee](#) on Jan. 18, the sites are located in Kennewick, Ridgefield, Spokane and Wenatchee. First Cases of U.K. COVID-19 Strain found in Two Counties in Washington state

The UW Medicine Virology Lab detected two cases of the COVID-19 variant, known as B.1.1.7 or SARS-CoV-2 VOC 202012/01 in specimens collected from two Snohomish County residents. Although these are the first detected B.1.1.7 variants in the state, it is likely that other cases exist and will come to light through ongoing surveillance. Department of Health Welcomes New Leader of Public-Private Vaccine Effort

The Washington State Department of Health (DOH) announced the appointment of Mr. Dan Laster as Director of the COVID-19 Vaccine Action Command and Coordination System (VACCS) Center to create public-private partnerships. In this role, Mr. Laster will tap into the unique capabilities and resources of the private sector to support vaccination efforts across the state of Washington. Biden Administration Unveils National Vaccine Strategy

On January 15, President Biden and his administration unveiled the outline for a national COVID-19 vaccination strategy, which seeks to address challenges faced by local governments in distributing the vaccine. This five-part plan outlines key actions that the Biden Administration will work to take at the federal level to aid the efficient and equitable vaccination of U.S. residents. Such actions include:


1. *Increasing the number of vaccinations* by encouraging states to open vaccine availability to other priority groups and ensuring an equitable distribution by targeting resources to hard-hit, marginalized, and medically underserved communities.
2. *Leveraging federal agency resources to create more local vaccination sites*, through the development of mobile vaccination clinics that will reach underserved urban areas and rural communities; and the formation of partnerships with pharmacies and Federally Qualified Health Centers (FQHCs).
3. *Increasing the supply of COVID-19 vaccines* to be deployed as quickly as possible through the enactment of the Defense Production Act.
4. *Mobilizing additional personnel* to get more shots in arms with a commitment to invest in 100,000 new public health workers that will work in their communities and provide vaccine outreach and contact tracing services, as well as long term support to address ongoing threats to public health.
5. *Launching a public education campaign* to improve vaccine confidence in the general public.

The announcement of this plan followed the release of President Biden's \$2 trillion coronavirus rescue package, the [American Rescue Plan](#), which proposed the addition of \$20 billion in funds to state, local and tribal governments for vaccine deployment. The proposed funding would be in addition to the \$8.75 billion in vaccine distribution funds recently allocated by Congress in the latest [COVID-19 funding package](#).

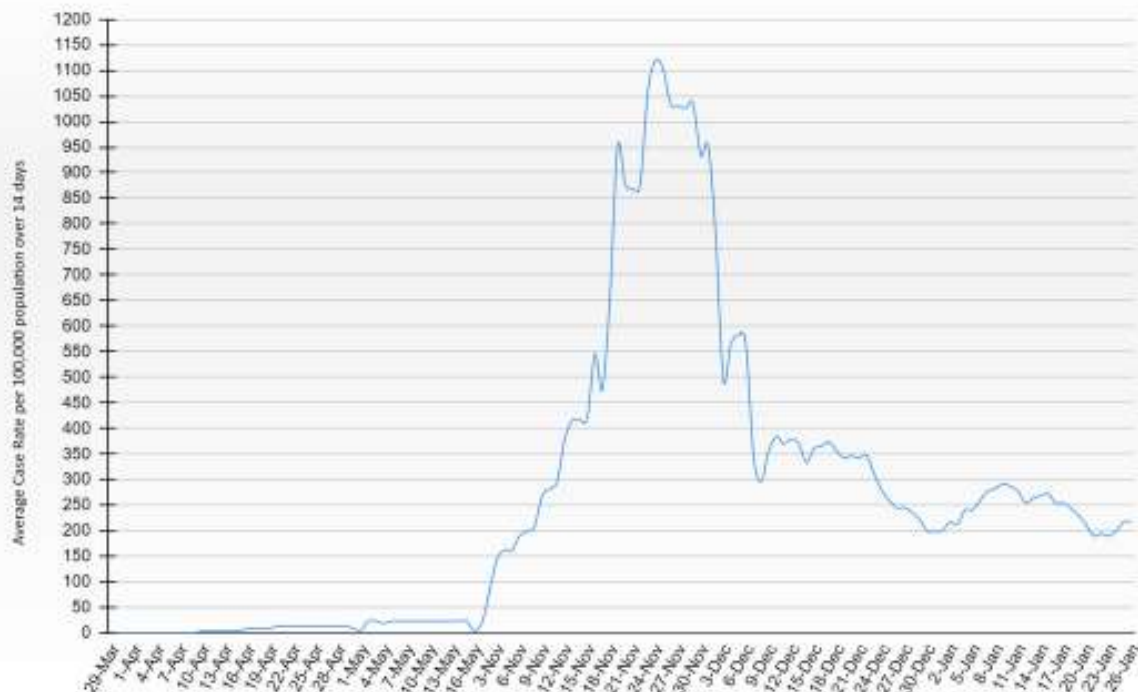
