As of August 22, **72.4%** of the population **12 and up** has received at least one dose.

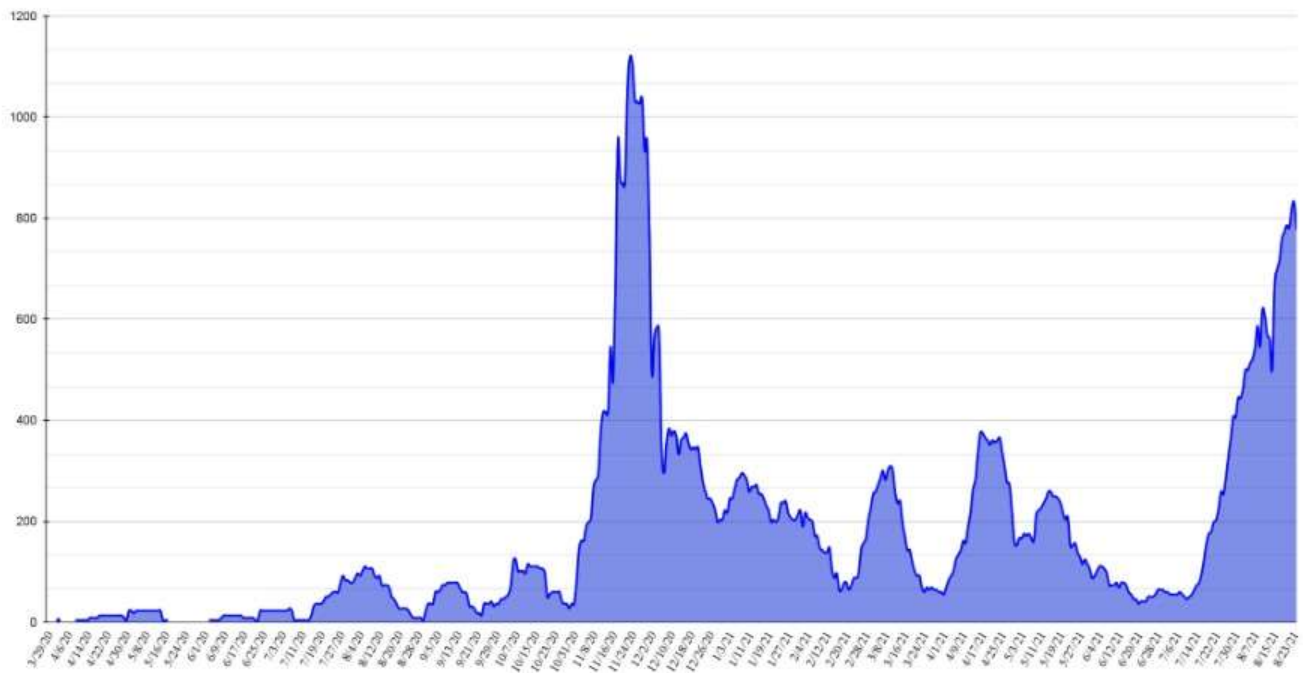

As of August 22, 72.4% of Washingtonians 12 and older have received at least one dose of COVID-19 vaccine. This number is higher than the DOH data dashboard because it includes state Immunization Information System (IIS) data, as well as aggregate data from the Department of Defense (DoD) and Veterans Affairs (VA):

4,727,583 people with at least one dose (4,574,996 IIS + 152,587 DoD and VA)
6,529,327 (Population 12 and older, 2020 Office of Financial Management estimates)
